Please send us your hearing aid in a "HARD CASE" so that the hearing aid is not damaged when it is mailed.

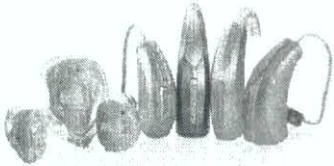
